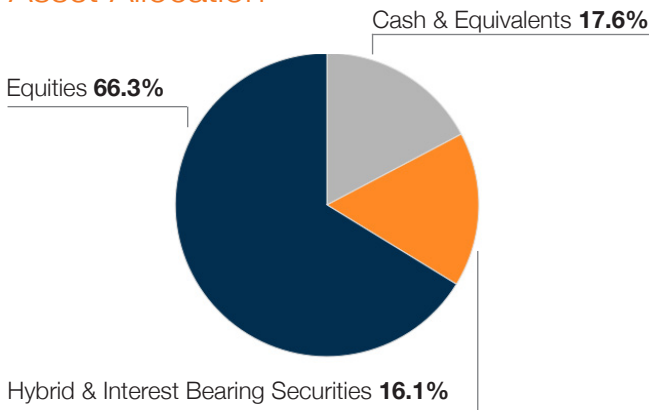

Asset Allocation



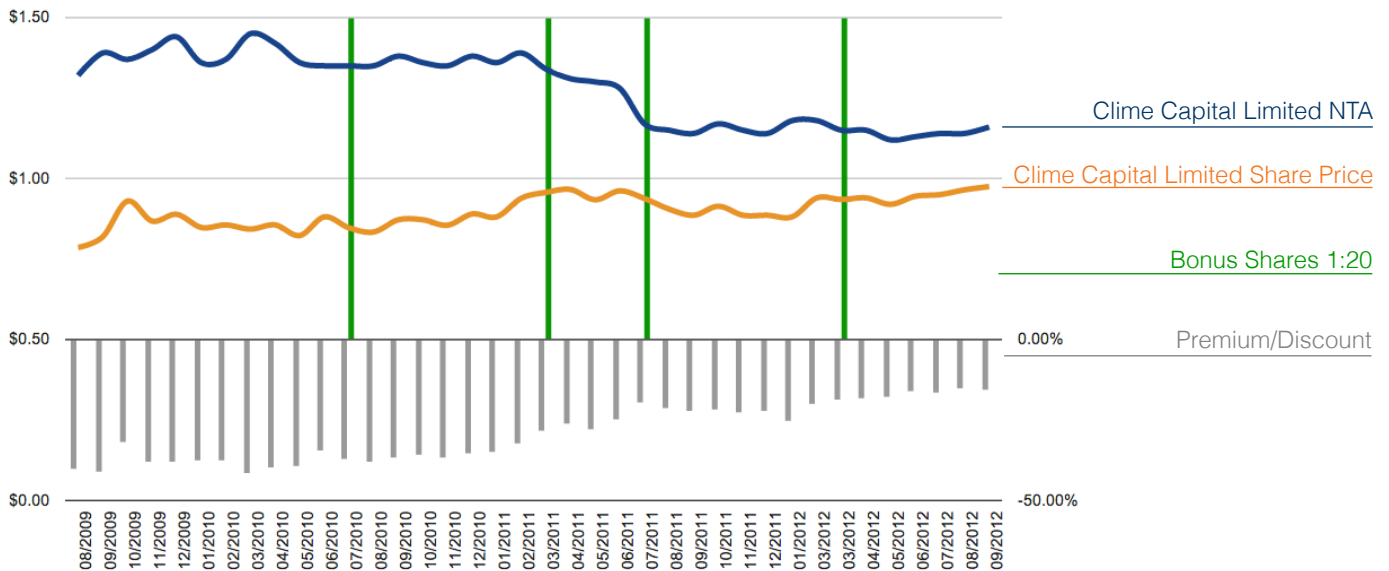
